The Court, having considered the record in this case, specifically including the Verified Complaint and the Certificate of Public Interest, and after having found Plaintiff has met its burden under A.R.S. § 13-2314(C); § 44-1007 (4)(b) and (c); § 12-1242; and Rule 66 Arizona Rules of Civil Procedure and ordered the appointment of a Receiver for the Mango Trust by sealed order dated April 16, 2014, and now being

1 advised in the premises that Plaintiff has selected Michael J. FitzGibbons as Receiver
2 for the Mango Trust;

3 **IT IS ORDERED** that Michael J. FitzGibbons is appointed Receiver for Mango
4 Trust and all of its entities specifically including:

5 X-1, LLC; Magic Wand Services, LLC; Occidental Resources Group,
6 LP; Occidental Management Group which owns the remaining 2% of
7 Occidental Resources Group, LP (ORG); E.A.P. Trust which owns
8 International Marketing Systems, which owns G.M.S. LLC, a Xango,
9 LLC Distributorship operating overseas but under the umbrella of X-1,
10 Inc./X-1, LLC to conduct foreign sales and financial transactions;
11 Catshaker Family Trust, Inc.; SLADUR, owned by O.R.G. and managed
12 by Laundry Unkefer; Black Rock, Inc.; and X-1 Global, LLC,
13 (“Receivership Defendants”) and any affiliates or subsidiaries controlled by the
14 Receivership Defendants, and of all Receivership Assets, with the full power of an
15 equity receiver, as contained and directed in the Sealed Order of this Court dated April
16 16, 2014.
