- 2. Pursuant to Order Re: Petition No. 1 the Court approved the Receiver's compensation at the rate of \$275.00 per hour together with all reasonable costs and expenses incurred relating to these services as Receiver. These services are billed by and paid to the Receiver's firm, FitzGibbons and Company, Inc.
- 3. Pursuant to this Court's Order Re: Petition No. 1, the Receiver has engaged the services of the law firm of Guttilla Murphy Anderson, P.C., of Phoenix, Arizona, and the Receiver has agreed to pay the law firm compensation at agreed hourly rates for the services of the firm together with all reasonable costs and expenses incurred on behalf of the Receiver.
- 4. Pursuant to the Court's Order Re: Petition No. 2 the Receiver is authorized to file this fee petition without including as exhibits the itemized of services rendered to, and costs incurred or expended on behalf of, the Receivership, provided that the pay petition includes a statement that anyone desiring additional information concerning the services and costs to be paid under the pay petition may obtain redacted information from the Receiver by delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a written request specifying the additional information requested at least three (3) days prior to the date set for hearing on the pay petition. The Court's Order Re: Petition No. 2 further provides that upon request of the Court, the Receiver shall make available for in camera review by the Court the itemized statements and supporting documentation for the services and costs to be paid under the pay petition.

- 5. The Receiver has submitted an itemized statement for services rendered to this Receivership and for reimbursable costs incurred or paid during the period from October 1, 2017 through October 31, 2017. The total amount requested for payment by the Receiver is \$1,273.97. The Receiver believes that this amount is reasonable and should be paid from the Receivership Assets.
- 6. The law firm of Guttilla Murphy Anderson, P.C., has submitted an itemized statement for services rendered to this Receivership and for reimbursable costs incurred or paid during the period from October 1, 2017 through October 31, 2017. The total amount requested for payment by the law firm of Guttilla Murphy Anderson, P.C. is \$1,165.00. The Receiver believes that this amount is reasonable and should be paid from the Receivership Assets and has therefore approved this statement for payment.
