16 Michael J. FitzGibbons, as the court appointed Receiver, respectfully petitions the

17 Court as follows:

18 1. On April 16, 2014, this Court entered its *Order Appointing Receiver*, which
19 appointed Michael J. FitzGibbons as Receiver of Mango Trust; X-1, LLC fka X-1, Inc.;
20 Magic Wand Services, LLC; Occidental Resources Group, LP; Occidental Management,
21 LLC; E.A.P. Trust; International Marketing Systems; G.M.S. LLC; Catshaker Family Trust,
Inc.; SLADUR; Black Rock, Inc.; and X-1 Global, LLC. ("Receivership Order").

1 2. Pursuant to this Court's *Order Appointing Receiver*, the Receiver has engaged
2 the services of the accounting firm of Henry & Horne, LLP of Tempe, Arizona to prepare
3 income tax returns for the Receivership and Mango Trust and Occidental Resource Group,
4 L.P. The Receiver has agreed to pay Henry & Horne, LLP compensation at agreed hourly
5 rates for the services of the accounting firm together with all reasonable costs and expenses
6 incurred on behalf of the Receiver.

7
8 3. Pursuant to the Court's *Order Re: Petition No. 2* the Receiver is authorized to
9 file this fee petition without including as exhibits the itemized of services rendered to, and
10 costs incurred or expended on behalf of, the Receivership, provided that the pay petition
11 includes a statement that anyone desiring additional information concerning the services and
12 costs to be paid under the pay petition may obtain redacted information from the Receiver by
13 delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a
14 written request specifying the additional information requested at least three (3) days prior to
15 the date set for hearing on the pay petition. The Court's *Order Re: Petition No. 2* further
16 provides that upon request of the Court, the Receiver shall make available for in camera
17 review by the Court the itemized statements and supporting documentation for the services
18 and costs to be paid under the pay petition.

19 4. The accounting firm of Henry & Horne, LLP, has submitted itemized
20 statements for services rendered to this Receivership and for reimbursable costs incurred or
21 paid during the period from September 11, 2015 through January 31, 2016 in connection with
the preparation of the 2015 Federal and Arizona Fiduciary Income Tax Returns and

1 preparation of the 2015 Federal and Arizona NOL Carryback Claims. The total amount
2 requested for payment by the accounting firm of Henry & Horne, LLP is \$5,950.00. The
3 Receiver believes that this amount is reasonable and should be paid from the Receivership
4 Assets and has therefore approved this statement for payment.

5 WHEREFORE, the Receiver respectfully requests that the Court enter an order
6 authorizing the Receiver to pay from Receivership Assets the amount of \$5,950.00 to the
7 accounting firm of Henry and Horne, LLP, for services rendered and costs incurred or paid
8 during the period September 11, 2015 through January 31, 2016:
