PETITION TO SET RECEIVER'S FEES  
AND APPROVE THE ENGAGEMENT  
OF FITZGIBBONS AND COMPANY,  
INC., AND GUTTILLA MURPHY  
ANDERSON, P.C.

(Assigned to Judge Douglas L. Rayes)

14 Michael J. FitzGibbons, as the court appointed Receiver, respectfully petitions the

15 Court as follows

16 1. On April 16, 2014, this Court entered its *Order Appointing Receiver* appointing  
17 a receiver of all assets of the Mango Trust including X-1, LLC; Magic Wand Services, LLC;  
18 Occidental Resources Group, LP; Occidental Management Group; E.A.P. Trust; International  
19 Marketing Systems; G.M.S. LLC; X-1, Inc.; Catshaker Family Trust, Inc.; SLADUR; Black  
20 Rock, Inc.; and X-1 Global, LLC ("Receivership Entities"). On April 22, 2014, the Court  
21 entered its *Order Appointing Michael J. Fitzgibbons Receiver*, which appointed Michael J.

1 FitzGibbons as Receiver of the Receivership Entities. These two orders are referred to  
2 hereafter as the "Receivership Order".

3 2. The Receivership Order did not set the Receiver's compensation rate.

4 3. The Receiver requests that the hourly compensation for the Receiver be set at  
5 the rate of \$275.00 per hour.

6 4. The Receivership Order further authorized the Receiver to employ such  
7 employees, accountants and attorneys as are necessary in the performance of the Receiver's  
8 duties.

9 5. The Receiver requests that the Court approve the Receiver's use of the  
10 Receiver's consulting firm, FitzGibbons and Company, Inc., to provide forensic accounting,  
11 financial reporting and other professional support services to the Court for the benefit of the  
12 receivership estate. The Receiver requests that FitzGibbons and Company, Inc. be  
13 reimbursed for all reasonable costs and expenses incurred on behalf of the Receiver and that  
14 FitzGibbons and Company, Inc. be compensated as provided in the Engagement Agreement,  
15 a copy of which is attached as Exhibit "A" to this Petition.

16 6. The compensation rate requested above for the Receiver and the rates set forth  
17 in Exhibit "A" for services provided by the staff of FitzGibbons and Company, Inc., are  
18 reasonable in light of the substantial experience of the Receiver and his company.

19 FitzGibbons and Company, Inc. is a full consulting firm which specializes in forensic  
20 accounting, litigation support and receivership services. Michael J. FitzGibbons is a Certified  
21

1 Public Accountant licensed in the state of Arizona and Indiana and has served as the receiver  
2 or as the deputy receiver in more than twenty (20) court supervised receiverships.

3 7. The Receiver has, subject to this Court's approval, entered into an Engagement  
4 Agreement with Guttilla Murphy Anderson, P.C. ("Guttilla Murphy Anderson, P.C."), a copy  
5 of which is attached as Exhibit "B" to this Petition. The Receiver requests that Guttilla  
6 Murphy Anderson, P.C., be appointed as general counsel to the Receiver and that it be  
7 compensated as provided in Exhibit "B".

8 8. Guttilla Murphy Anderson, P.C. is qualified to serve as counsel to the Receiver  
9 and the rates set forth in Exhibit "B" are reasonable in light of the substantial experience of  
10 Guttilla Murphy Anderson, P.C. in serving as legal counsel to court appointed receivers.  
11 Guttilla Murphy Anderson, P.C. has served as legal counsel to court appointed receivers in  
12 over 100 state and federal court receiverships, in actions brought by the Securities and  
13 Exchange Commission, the Federal Trade Commission, the Commodities Future Trading  
14 Commission, the Arizona Banking Department, the Arizona Attorney General, and the  
15 Insurance Departments of Arizona, California, Illinois, Indiana, Texas, and Vermont as well  
16 as actions brought by private litigants.


17 WHEREFORE, the Receiver respectfully requests that the Court enter an Order:

- 18 1. Setting the Receiver's compensation at \$275.00 per hour.
- 19 2. Authorizing the Receiver to use the Receiver's consulting firm, FitzGibbons  
20 and Company, Inc., to provide forensic accounting and litigation support and other support  
21 services to the Receiver, and approving the Engagement Agreement attached as Exhibit "A".
