15 Michael J. FitzGibbons, as the court appointed Receiver, respectfully petitions the  
16 Court as follows:

17 1. On April 16, 2014, this Court entered its *Order Appointing Receiver*, which  
18 appointed Michael J. FitzGibbons as Receiver of Mango Trust; X-1, LLC fka X-1, Inc.;  
19 Magic Wand Services, LLC; Occidental Resources Group, LP; Occidental Management,  
20 LLC; E.A.P. Trust; International Marketing Systems; G.M.S. LLC; Catshaker Family Trust,  
21 Inc.; SLADUR; Black Rock, Inc.; and X-1 Global, LLC. (“Receivership Order”).

1           2. Pursuant to *Order Re: Petition No. 1* the Court approved the Receiver's  
2 compensation at the rate of \$275.00 per hour together with all reasonable costs and expenses  
3 incurred relating to these services as Receiver. These services are billed by and paid to the  
4 Receiver's firm, FitzGibbons and Company, Inc.

5           3. Pursuant to this Court's *Order Re: Petition No. 1*, the Receiver has engaged the  
6 services of the law firm of Guttilla Murphy Anderson, P.C., of Phoenix, Arizona, and the  
7 Receiver has agreed to pay the law firm compensation at agreed hourly rates for the services  
8 of the firm together with all reasonable costs and expenses incurred on behalf of the Receiver

9           4. Pursuant to the Court's *Order Re: Petition No. 2* the Receiver is authorized to  
10 file this fee petition without including as exhibits the itemized of services rendered to, and  
11 costs incurred or expended on behalf of, the Receivership, provided that the pay petition  
12 includes a statement that anyone desiring additional information concerning the services and  
13 costs to be paid under the pay petition may obtain redacted information from the Receiver by  
14 delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a  
15 written request specifying the additional information requested at least three (3) days prior to  
16 the date set for hearing on the pay petition. The Court's *Order Re: Petition No. 2* further  
17 provides that upon request of the Court, the Receiver shall make available for in camera  
18 review by the Court the itemized statements and supporting documentation for the services  
19 and costs to be paid under the pay petition.

20           5. The Receiver has submitted an itemized statement for services rendered to this  
21 Receivership and for reimbursable costs incurred or paid during the period from October 1,

1 2023 through October 31, 2023. The total amount requested for payment by the Receiver is  
2 \$553.75. The Receiver believes that this amount is reasonable and should be paid from the  
3 Receivership Assets.

4         6. The Receiver has submitted an itemized statement for services rendered to this  
5 Receivership and for reimbursable costs incurred or paid during the period from November  
6 1, 2023 through November 30, 2023. The total amount requested for payment by the  
7 Receiver is \$608.75. The Receiver believes that this amount is reasonable and should be  
8 paid from the Receivership Assets.

9         7. The Receiver has submitted an itemized statement for services rendered to this  
10 Receivership and for reimbursable costs incurred or paid during the period from December 1,  
11 2023 through December 31, 2023. The total amount requested for payment by the Receiver  
12 is \$1,008.75. The Receiver believes that this amount is reasonable and should be paid from  
13 the Receivership Assets.

14         8. The law firm of Guttilla Murphy Anderson, P.C., has submitted an itemized  
15 statement for services rendered to this Receivership and for reimbursable costs incurred or  
16 paid during the period from October 1, 2023 through October 31, 2023. The total amount  
17 requested for payment by the law firm of Guttilla Murphy Anderson, P.C. is \$237.42. The  
18 Receiver believes that this amount is reasonable and should be paid from the Receivership  
19 Assets and has therefore approved this statement for payment.

20         9. The law firm of Guttilla Murphy Anderson, P.C., has submitted an itemized  
21 statement for services rendered to this Receivership and for reimbursable costs incurred or

1 paid during the period from November 16, 2023 through December 31, 2023. The total  
2 amount requested for payment by the law firm of Guttilla Murphy Anderson, P.C. is  
3 \$243.50. The Receiver believes that this amount is reasonable and should be paid from the  
4 Receivership Assets and has therefore approved this statement for payment.

5 WHEREFORE, the Receiver respectfully requests that the Court enter an order  
6 authorizing the Receiver to pay from Receivership Assets:

7 1. The amount of \$553.75 to FitzGibbons and Company, Inc. for services  
8 rendered and costs incurred or paid during the period October 1, 2023 through October 31,  
9 2023;

10 2. The amount of \$608.75 to FitzGibbons and Company, Inc. for services  
11 rendered and costs incurred or paid during the period November 1, 2023 through November  
12 30, 2023;

13 3. The amount of \$1,008.75 to FitzGibbons and Company, Inc. for services  
14 rendered and costs incurred or paid during the period December 1, 2023 through December  
15 31, 2023;

16 4. The amount of \$237.42 to Guttilla Murphy Anderson, P.C., for services  
17 rendered and costs incurred or paid during the period October 1, 2023 through October 31,  
18 2023; and

19 5. The amount of \$243.50 to Guttilla Murphy Anderson, P.C., for services
