The total amount requested for payment by the Receiver is \$255.00. The Receiver believes that this amount is reasonable and should be paid from the Receivership Assets.
- 7. The Receiver has submitted an itemized statement for services rendered to this Receivership and for reimbursable costs incurred or paid during the period from March
