- 5. Pursuant to the Court's Order Re: Petition No. 2 the Receiver is authorized to file this fee petition without including as exhibits the itemized of services rendered to, and costs incurred or expended on behalf of, the Receivership, provided that the pay petition includes a statement that anyone desiring additional information concerning the services and costs to be paid under the pay petition may obtain redacted information from the Receiver by
