14 Michael J. FitzGibbons, as the court appointed Receiver, respectfully petitions the
15 Court as follows:

16 1. On April 16, 2014, this Court entered its *Order Appointing Receiver*, which
17 appointed Michael J. FitzGibbons as Receiver of Mango Trust; X-1, LLC fka X-1, Inc.;
18 Magic Wand Services, LLC; Occidental Resources Group, LP; Occidental Management,
19 LLC; E.A.P. Trust; International Marketing Systems; G.M.S. LLC; Catshaker Family Trust,
20 Inc.; SLADUR; Black Rock, Inc.; and X-1 Global, LLC. (“Receivership Order”).

1 2. On November 22, 2016, this Court entered its *Order Adjudicating Request for*
2 *Compensation Re: Petition No. 16*, which approved the Receiver’s final recommendations on
3 Requests for Compensation that had been received by the Receiver pursuant to the procedures
4 established by the Court (“2016 Adjudication Order”).

5 3. As of December 31, 2016, the Receivership estate held \$1,447,231 in cash.
6 *See* the receivership accounting attached as **Exhibit “A”**.

7 4. The Receiver recommends that \$1,000,000 of the available cash in the
8 receivership be distributed pro-rata on the Requests for Compensation previously approved
9 by the Court (First Interim Distribution”). Attached as Exhibit “B” is a schedule of the First
10 Interim Distribution showing for each Request for Compensation approved by the Court, the
11 correct name of the Victim, the approved amount of the Economic Loss for that Victim, the
12 name of the Payee to receive part of all of the Victim’s pro-rata share of the First Interim
13 Distribution, and the amount of each payment.

14 5. The schedule attached as **Exhibit “B”** contains several Requests for
15 Compensation that have been conditionally approved by the Court but which are incomplete
16 because the Receiver has not yet been provided with the necessary documents to establish the
17 Requestor’s (Payee on the exhibit) right to receive payment on these Request for
18 Compensations.¹ The pro-rata share of the First Interim Distribution payable on these

5 b. Chance, Anna Lee (#210). The Receiver recommended and the Court
6 approved an economic loss of \$181,865 for this Victim. The Victim is deceased and
7 the Receiver has now received completed documentation showing that this Victim left
8 her estate to her two sons, John H. Chance and Philip G. Chance. John Chance is
9 living but has not yet provided documentation evidencing his rights to a portion of
10 distributions on this victim's loss. Philip G. Chance survived Anna Lee Chance but is
11 now deceased and the Receiver has been provided with documentation demonstrating
12 that his assets were transferred to the Philip G. Chance & Carol R. Chance Revocable
13 Living Trust. Carol Chance is the sole surviving beneficiary of the Trust.
14 Accordingly, the Receiver recommends that 50% of the First Interim Distribution of
15 \$23,159.11 for this Victim's loss be distributed to David Chance, as Trustee of the
16 Philp G. Chance & Carol R. Chance Revocable Living Trust and that the remaining
17 50% be retained by the Receiver until the proper documentation has been provided to
18 the Receiver.

4 WHEREFORE, the Receiver respectfully requests that the Court enter an order:

5 1. Approving an Interim Distribution on approved Requests for Compensation in
6 the total amount of \$1,000,000.00;

7 2. Authorizing the Receiver to pay the Interim Distribution to the approved
8 Requestors/Payees and in the amounts indicated on **Exhibit "B"**, provided that the amounts
9 payable to those Requestors/Payees which have been classified in Exhibit "B" as Class 1(A)
10 or 2(A) shall be withheld until such time as the Requestor/Payee has provided all of the
11 documentation required by the Receiver; and

12 3. Granting such other relief as the Court deems appropriate.
